## Minutes of June 19, 2023, Meeting- Forest Lakes Club

# Treasurer's Report as of June 19, 2023

We currently have \$36,969.26 in the special assessment account, \$10,873.71 in the Byram Twp., escrow account, \$31,515.79 in the dam assessment account, \$34,517.71 in the MMF and \$163,244.80 in the operating account for a total of \$277,121.73.

A motion was made by Gary Branning and seconded by Debbie Devenny to accept the minutes of the May 8, 2023; meeting as read. The motion was unanimously approved.

## Discussion

Board member Greg Smith updated the board on the status of the Farmland Assessment. He and Dorothy Gorman met with our forester and our 2024 application was approved. A copy was delivered to the Byram Twp., tax accessor and another copy was mailed to the U.S. Forestry Service on Rt. 206 in Andover, New Jersey 07821.

Our Forester advised us that it has been 10 years since our last plan and we need to have a new one prepared this fall.

The board approved an estimate for clearing the vegetation on the dam as required by our agreement with NJ Dam Safety. The vegetation will be cleared sometime in June weather permitting. We also need small trees removed as well as some of the common reed at the bottom of the dam.

Gary Branning spoke with the owner of Samurai Roofing and was able to get a price adjustment of \$650.00. A motion was made by Debbie Devenny and seconded by Gary Branning to accept the estimate from Samurai Roof. The motion was passed unanimously.

There was a lengthy discussion of the playground equipment at Main Beach and Cove Beach. There are a couple of issues with the equipment which will be addressed immediately.

There is a large rock at main beach which needs to be spray painted so that it is more visible.

The new docks at Cove Beach we delivered and the swim team is delighted.

The summer News Bole is in production and expected to be emailed to the membership shortly.

There was a discussion of "email alerts". We only pay \$13.00 per month for our email alerts. We need to limit the number of emails we send out or the cost will go up significantly.
